

THE STANSTED AIRPORT LIMITED (LAND AT AND IN THE VICINITY OF STANSTED AIRPORT – NEW LOCAL ROADS IN CONNECTION WITH SECOND RUNWAY) COMPULSORY PURCHASE ORDER 2008

The Airports Act 1986
and the Acquisition of Land Act 1981

Stansted Airport Limited (in this order called “the acquiring authority”) makes the following order –

1. Subject to the provisions of this order, the acquiring authority is under section 59 of the Airports Act 1986 hereby authorised to purchase compulsorily the land described in paragraph 2 for the purpose of the provision of new local roads in connection with the expansion of Stansted Airport by the construction and operation of a second runway, terminal and associated facilities.
2. The land authorised to be purchased compulsorily under this order is the land described in the Schedule and delineated and shown coloured pink on a map prepared in duplicate, sealed with the common seal of the acquiring authority and marked “Map referred to in the Stansted Airport Limited (Land at and in the Vicinity of Stansted Airport – New Local Roads in Connection with Second Runway) Compulsory Purchase Order 2008”.
